DISTRIBUTION NOTICE

Aberdeen Emerging Markets Equity Income Fund, Inc. (NYSE American: AEF) (the “Fund”), a closed-end equity fund, today announced that it paid on September 30, 2020, a distribution of \$0.0437 per share to all shareholders of record as of September 21, 2020 (ex-dividend date September 18, 2020).

As announced on December 10, 2019, consistent with the Fund’s policy to pay distributions quarterly, comprised of net investment income generated by dividends paid from the Fund’s underlying securities, the Board determined the annualized distribution rate for the 2020 calendar year to 2.5%, payable quarterly, commencing with the March 2020 distribution. The determination was based on the Fund’s estimated dividend income over the period, net of taxes and expenses, is subject to ongoing review by the Board.

Under U.S. tax rules applicable to the Fund, the amount and character of distributable income for each fiscal year can be finally determined only as of the end of the Fund’s fiscal year. However, under Section 19 of the Investment Company Act of 1940, as amended (the “1940 Act”) and related Rules, the Fund may be required to indicate to shareholders the estimated source of certain distributions to shareholders.

The following table sets forth the estimated amounts of the sources of the distribution for purposes of Section 19 of the 1940 Act and the Rules adopted thereunder. The table has been computed based on generally accepted accounting principles. The table includes estimated amounts and percentages for this distribution and for the cumulative distributions paid relating to fiscal year to date (01/01/2020 – 08/31/2020), from the following sources: net investment income; net realized short-term capital gains; net realized long-term capital gains; and return of capital. The estimated composition of the distributions may vary from quarter to quarter because the estimated composition may be impacted by future income, expenses and realized gains and losses on securities and currencies. The securities held by the Fund pay dividends at various times throughout the year; therefore; the level of net income may vary significantly from quarter to quarter.
