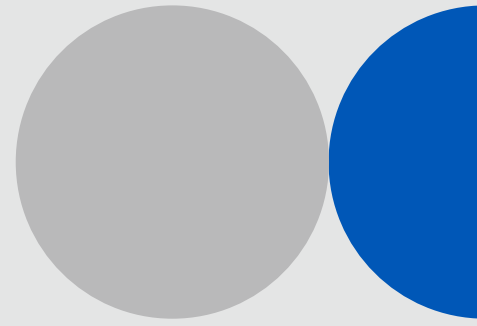

Investor eligibility

In order to open a staff ISA, you must be a MyFunds client with an existing staff account open with abrdn Fund Managers Ltd. One of the eligibility requirements for this ISA is for you to be an employee or pensioner. Employee means a current permanent employee (which includes fixed term employees but excludes temporary workers and contractors) of abrdn plc or each of its wholly-owned subsidiaries who has a current valid abrdn staff ID number. It also includes a person listed as a director of a company within the abrdn group on The Registrar of Companies for England and Wales, Scotland or Northern Ireland. A pensioner means an individual who was an employee immediately before his or her retirement, who is a current member of the abrdn group pension plan and who has a current valid abrdn group pension plan number. By making this application you are confirming that you meet the eligibility requirements set out in section 2.1 of the Staff & Pensioners Terms and Conditions, which include the above.

The Staff & Pensioners Terms and Conditions (including the availability of the special unit class) are not part of your contract of employment and can be changed in accordance with the Staff & Pensioners Terms & Conditions.
