Investment objectives

Aberdeen Sustainable MPS 4 aims to achieve a total return from both income and capital growth through a diversified portfolio of collective investment funds over the long term. It focuses on sustainable, ethical and impact funds and is intended for investors with a medium attitude to risk. It typically allocates a minimum of 90% of the portfolio to sustainable focused assets, with the remainder allocated to assets utilised for portfolio construction purposes. The portfolio invests in a variety of assets, typically in equities, fixed interest, alternatives and money markets. This blend of assets should help to dampen volatility over the longer term.




1. Environmental, Social and Governance (ESG) integration

ARC Private client indices

ARC Private Client Indices are based on actual client portfolio returns provided by various investment management companies. These portfolio returns are allocated to one of four categories based on the volatility of their returns relative to world equities, and an average return is calculated for each category.

Grouping portfolios by their volatility differs from the traditional approach, which compares portfolios which have similar asset allocations. Instead, investment managers may use whatever asset allocation they consider appropriate to achieve the desired levels of return and volatility.

Risks

ESG Risk: It is important for investors to be clear that the interpretation of sustainable and ESG related criteria is subjective, meaning that the fund may invest in companies which do not align with the personal views of individual investors. Credit risk: The fund invests in securities which are subject to the risk that the issuer may default on interest or capital payments.

Interest rate risk: The fund price can go up or down daily for a variety of reasons including changes in interest rates, inflation expectations or the perceived credit quality of individual countries or securities.

Equity risk: The fund invests in equity and equity related securities. These are sensitive to variations in the stock markets which can be volatile and change substantially in short periods of time.

Emerging Markets risk: The fund invests in emerging market equities and / or bonds.
