

# Investment objectives

Aberdeen Sustainable MPS 5 aims to achieve a total return from both income and capital growth through a diversified portfolio of collective investment funds over the long term. It focuses on sustainable, ethical and impact funds and is intended for investors with a medium high attitude to risk. It typically allocates a minimum of 95% of the portfolio to sustainable focused assets, with the remainder allocated to assets utilised for portfolio construction purposes. The portfolio invests in a variety of assets, typically in equities, fixed interest, alternatives and money markets. This blend of assets should help to dampen volatility over the longer term.






## Sustainable investing

#### Performance

#### **ARC Private client indices**

ARC Private Client Indices are based on actual client portfolio returns provided by various investment management companies. These portfolio returns are allocated to one of four categories based on the volatility of their returns relative to world equities, and an average return is calculated for each category.

Grouping portfolios by their volatility differs from the traditional approach, which compares portfolios which have similar asset allocations. Instead, investment managers may use whatever asset allocation they consider appropriate to achieve the desired levels of return and volatility.

#### Risks
