IMPORTANT INFORMATION - FUND CHANGES

Dear Investor,

ABRDN OEIC III - CHANGES TO THE INVESTMENT OBJECTIVE AND POLICY OF THE FUNDS

Please read this letter carefully as it contains important information regarding upcoming changes to the following funds:

abrdn MyFolio Managed I - V Funds abrdn MyFolio Market I - V Funds abrdn MyFolio Multi-Manager I - V Funds abrdn MyFolio Index I - V Funds abrdn MyFolio Sustainable I - V Funds abrdn MyFolio Sustainable Index I - V Funds (each the "Fund" and together the "Funds")

No action is required in response to this letter, but we would encourage you to familiarise yourself with the changes, as you are invested in one or more of the impacted Funds.

In this letter, when we say 'we' or 'us', we mean abrdn Fund Managers Limited, the company that is currently responsible for managing and operating your investment in the Funds.

We regularly review our range of funds to ensure that they are best positioned to deliver positive outcomes for investors and appropriate in the current marketplace. As a result of a recent review, on 3 May 2024 ("Effective Date") we will make the following changes:

- Update to the investment objective section of each Fund to remove the Performance Comparator (as defined in the Fund's Prospectus) for each Fund.
- Update to the investment policy of each Fund in relation to the Fund's use of derivatives.



Updates to the Funds

1. Removal of the Performance Comparator

We have taken the decision to remove the reference to the Performance Comparator (a factor against which a fund manager invites investors to compare a fund's performance) for each Fund which is currently outlined within the Investment Objective and Policy (IOP) section of the Fund's Prospectus.

As the Funds are managed to a defined level of risk (as measured against world stock markets over a 10 year period), the asset mix within them (including assets such as equities (company shares) and bonds (which are like loans to companies or governments that pay interest)) will change depending on the views of the fund manager in order to achieve the investment objective of the Funds in the most optimal manner. The Performance Comparator is less dynamic and less detailed in asset allocation given it only represents performance of equities and cash the weighting of which corresponds with each Fund's level of risk. This means that the Performance Comparator does not provide a close comparison of the expected fund performance and therefore we have decided to remove it.

We don't use the Performance Comparator to manage the Funds, they are just provided so you can see how your Fund is performing in comparison with that Performance Comparator.

From the Effective Date, you will be able to assess the performance of each Fund against the relevant equity category of the Morningstar Allocation peer group. This peer group consists of funds with a broadly corresponding equity allocation to each Fund. Although the asset mix within each category provides a better reflection of the asset allocation within each Fund, it should be noted that the funds in each category will have other varying characteristics in terms of objectives, investment policies and levels of risk. Therefore, whilst the peer group can be used as an indicator for assessing performance over the long term in comparison to peers, it does not provide an exact like-for-like basis for comparison. When assessing the performance of the fund against peers, you should also take into account that each Fund's primary objective is to achieve long term growth whilst being within the defined risk level, as set out in the IOPs for each Fund. Further details on the fund, including the risk levels and fund performance data, is published at www.abrdn.com under "Fund Centre".

We believe this provides an appropriate way of assessing performance of risk managed funds.

2. Derivatives and Techniques

The current Investment Policy sets out that the Funds are not expected to invest in derivatives (derivatives are linked to the value of other assets. In other words, they derive their price from one or more underlying asset) directly. However, in order to create efficiencies in portfolio management, the Derivative and Techniques section of the IOP will be updated to reflect that going forward we will have the flexibility to utilise derivatives for the purposes of Efficient Portfolio Management. We believe this change will benefit investors by allowing the management team to reduce cost and/risk or generate additional income or growth (which is what we mean when we say Efficient Portfolio Management) where applicable in its management of the Fund.

Each Fund will remain within the existing risk profile parameters and the Synthetic Risk and Reward Indicator ("SRRI") as set out in the Key Investor Information Documents ("KIIDs") will remain the same.

Expenses

We will meet the expenses arising as a result of these changes, including all administrative expenses and other professional adviser expenses.

Other information

No action is required from you and this notification is for information only. Our fund documentation, including the Prospectus and KIIDs, will be updated to reflect the changes set out in this letter on the Effective Date. Please also note that all share classes in all Funds will be impacted by this change (see Appendix 1 for the full list of available share classes).
